OUT OF ZONE ENROLMENT PRIORITY (please tick your priority)

The order of priority in which applicants who live outside our school's home zone are offered places at our school is, as follows:

first priority must be given to any applicant who is accepted for enrolment in a special programme run by the school (not applicable at GBS)

second priority must be given to any applicant who is the sibling of a current student of the school

third priority must be given to any applicant who is the sibling of a former student of the school

fourth priority must be given to any applicant who is a child of a former student of the school

fifth priority must be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school

sixth priority must be given to all other applicants

Advertisements for any out of zone places (if required), will be published on our website and in a community newspaper local to the school.

If there are more applicants in the second, third, fourth, fifth or sixth priority groups than there are places available, selection within the priority group will be by ballot conducted in accordance with instructions issued by the Secretary under Section 11G of the Education Act 1989.

Out of Zone applicants will be notified by mail and email of their acceptance at Green Bay School from either the ballot or their position on the waiting list.
